Payment Options:

1.Option 1. Full Year Tuition Registration Discount 10% when paid by 1st July 2018 (Not Applicable where sibling or family discount has been applied)Registration Fee \$50

2.Option 2. Full Year Tuition Registration 5% Discount paid in 2 Installments first with Registration when 1st installment paid by 1st July 2018 and 2nd due January 1st 2019. Registration fee \$50

3.Option 3. Full Year Tuition Registration paid in 10 monthly installments due on the 1st day of each month. First Month due with Registration plus \$50.00 Registration fee. Please note that all monthly payments fall due by the 1st of each month from September 1st 2018 to June 1st 2019 and all payments received after the 1st of each month incur a \$20.00 late fee.

4. Ongoing enrollments tuition is pro-rated from the date of students commencement

Danceartist's also provides supplementary Royal Academy of Dance Examination preparation classes/coaching to fellow Teachers registered with the Royal Academy of Dance and Hybrid Movement Co Movement as Metaphor training programs, Workshops and Summer Intensives.

Students/Parents/Adults are expected to conduct themselves in an orderly polite manner at all times whilst at the Danceartist's Ballet Academy premises. Danceartist's reserves the right to refuse service.

Please email Danceartist's to arrange suitable make up lessons for your child. No credits or refunds for cancellations however many make up classes to select from and where necessary Danceartist's adds extra lessons to the weekly schedule.

Lessons missed due to illness may be made up by attending another class by arrangement with the director, when a doctors certificate is provided. If your child misses lessons due to other chosen activities or holidays, whilst Danceartist's will endeavor to find a lesson for your child to make up their missed lesson, Danceartist's is under no obligation to do so.

Danceartist's reserves the right to cancel any classes or change the faculty teacher on short notice. Classes canceled by Danceartist's may be made up by attending another lesson from our studio Schedule. Please contact us via email :danceartistscc@gmail.com to arrange all make up classes.

Danceartists Tuition is non refundable however unused hours due to illness remain as credits for future classes only. Students who arrive late to their class cannot make up their missed time by attending parts of other classes.

All the performance and costume fees are non-refundable and must be submitted before or by the due date. Chewing gum, food and drinks excluding water are not permitted in the studio. Water is permitted in the studio and students may bring their water bottles into the studio with them.

Class viewing: During the year Danceartists Ballet Academy has two separate "Open weeks". Parents may also view classes by making individual appointments through out the year..

Grievance Procedure: Should you have a grievance associated with your child's or your own experience at the Danceartist's Ballet Academy please explain the nature of your grievance verbally in writing to Danceartist's Ballet Academy personnel most directly involved. Please take into consideration that any action taken, whether formal or informal, should be handled in a private, co-operative, and dignified manner.

Drop off and pick up of students: Transport to and from Danceartist's Ballet Academy is the responsibility of the parents. At Drop off, parents are to bring their children into the studio premises to drop them off to class. At Pick up, parents must enter the studio premises and pick up their children from inside the studio premises. Students are not permitted to wait for parents outside the studio premises.

Parents are asked to be punctual to pick up their child/children after class. *Should a parent be late picking up their child, the student/s must stay inside the studio premises to wait for their parents. Should this happen Students are asked to sit quietly and watch the next class until their parent arrives. Danceartists is not responsible for students outside of their lesson times. However, Danceartist's faculty will not leave a student by themselves at the studio after closing time. Should unforeseen circumstances arise where a parent cannot arrange transport for their child after classes, Danceartists faculty will endeavor to make contact with the parents and emergency contacts. However, if contact is unsuccessful Danceartists will provide supervised transport home for the student. Costs for transport remain the responsibility of the parent. Extra child care time outside of Danceartist's Class hours is Billed at \$20 per hour.

Dress Code: All students are expected to maintain a neat appearance and to abide by the specified dress code.

Please choose one pastel and one dark. White, grey, Pink Legwarmers. Blochs variation half tutu provided on loan from Danceartists.
