By enrolling in any class at Danceartists Ballet Academy all students, student parents and adults agree to the following: Danceartists School Policy and Code of Conduct

Students / Parents / Adults are expected to conduct themselves in an orderly and polite manner at all times while at DanceArtist's Ballet Academy premises, performance venues, and examination venues and the Maironis Club privately owned Parking area. It is cause for immediate dismissal from DanceArtists if a parent is deemed to have behaved in an aggressive manner towards students and or staff and faculty or has filmed students and faculty without their permission. Only students and staff are allowed in the dressing room. For the safety and well being of our students, staff, and faculty our premises DanceArtists reserves the right to refuse service.

Tardiness: Students should arrive ready for their class 10 minutes before their class time and be ready to walk into the studio at their class time. Warm up is imperative in Ballet Class, please be on time so that your child does not miss these very important warm up beginning of class exercises. Students arriving 10 minutes late will be asked to sit and observe their class. Please phone or message the studio if your child is arriving late to a lesson. Arriving late is disruptive to the Class in progress. Excessive tardiness or absence will result in the dancer forfeiting performance opportunities. Parents must pick up students no more than 15 minutes after class ends.

Parents and students are required to understand and abide by the laws of Massachusetts regarding surreptitious electronic recording of conversations between people who have not consented such as in an office or public setting. Unauthorized or illegal recordings of conversations or shared text messages can be cause for a civil lawsuit for invasion of privacy. Parents are expected to explain the legal responsibilities of cell phone use in a public place to your children. Student cell phones are not permitted in class and to be turned off or silenced during class.

All the performance and costume fees are non-refundable and must be submitted before or by the due date. Any costs associated with damage to Danceartists Costumes caused by students are the responsibility of the students parent. Street shoes, Chewing gum, food and drinks excluding water are not permitted in the studio.

Observation: Parents are not allowed to enter the studio when classes are in session. Please do not interrupt classes. If you wish to speak with an instructor, please schedule an appointment at our Office or email us at admin@danceartistsballetacademy.com.

Viewing your child's class: Parents may view their child's Private Coaching classes in person throughout the year. Open weeks for Parents to view Group Classes are in the month of February and June by appointment.

Please mark your child's full name on every piece of Dance attire and any other personal belongings which your child may bring to the studio. Please DO NOT bring valuables to the studio. DanceArtists is not responsible for any items lost, stolen, or damaged on thestudio premises.

Photography or videography is prohibited at DanceArtists - including any Danceartist's Ballet Academy classes, performance or dress rehearsal regardless of location due to copyright restrictions associated with music, choreography, and costumes. Proprietary Rights: Use of Danceartists Ballet Academy and its Faculty specific curriculum, steps or choreography for the benefit of a competing business is strictly prohibited.

Non-Solicitation: Students and /or Parents shall not solicit, recruit, or entice any current students, families, or staff of Danceartists Ballet Academy to join or work for another dance studio, private program, or competitive team.

Restitution Clause: In the event of a breach of this non-solicitation policy, the student /parent acknowledges that such actions cause material financial harm to Danceartists Ballet Academy. The student /parent agrees to pay Danceartists Ballet Academy liquidated damages and restitution for the loss of business or staff member lost due to solicitation.

Grievance Procedure Should you have a grievance associated with your child's or your own experience at DanceArtist's Ballet Academy please explain the nature of your grievance in writing to Danceartist's Ballet Academy. Please note that any action taken (formal or informal) will be handled in a co-operative, and dignified manner by DanceArtists Administration

Safe Pointe Work requires a minimum of 3 days per week of Ballet for 3 years to build the required technical strength and growth plate development in the feet along with strong core stability and lower back trained spinal alignment. Pointe readiness is assessed by our Director on an individual basis. Appropriate bone age of 12 is recommended for commencement of Pointe work. Each advancing RAD Vocational Level requires ever increasing advancing levels of pointe work. Danceartists Ballet Academy Director assesses when each student is physically proficiently ready in technical strength and core alignment biomechanics to move forward to more advanced pointe work. Students require diligence, consistency and patience along their individual path towards achieving strong beautiful execution of pointe work.

Drop-off and Pick-up Transport to and from DanceArtist's Ballet Academy is the responsibility of parents/guardians and students must arrive on time and enter the building at least 10 minutes before class. Pre-Professional Students may enter the studio to warm up at the barre 5 minutes before their Class time. DanceArtists is not responsible for students outside of their lesson times. Students should wait inside the waiting room. Extra child care time outside of Danceartists daily closing times is billed at \$25 per hour.

Danceartists Ballet Academy School Policy and Code of Conduct continued

Student Recommendations: To be eligible for consideration for college recommendations of any kind, a student must attend a minimum of 3 years training on Danceartists Pre-Professional Dancers Program. Recommendations and references are at the Director's discretion.

Dress Code: All Danceartists girl's school uniform leotards for ALL LEVELS are available to purchase at Danceartists. Boys uniform please see Uniform page.

Royal Academy of Dance Exams -

RAD Exams are NOT mandatory and every student is taught the same beautiful RAD Syllabus. Exam readiness and invitation is decided by the Director. Final decisions on a student's readiness for their RAD exam, up to and including the Exam dates, are at the Directors discretion. College entry accredited credits are gained for each exam. Minimum training days recommended for RAD exam preparation are non negotiable and consistency in attendance arranged on an individual basis is mandatory. Students who train in ballet classes elsewhere at any time during the year do not qualify for Invitation to the prestigious RAD examination selection through our Director Joanna Duncan RTS ARAD Solo Seal. Exceptions are Danceartists Master classes or Intensives when recommended by the Director. Conditions apply so make an appointment to discuss options. At Danceartists we enter our exams under the credentials of our Director with our examinations either filmed, in person with an RAD Examiner, or at the official RAD examination center at Montclair State University or the Royal Academy of Dance designated East Coast Examination Center. Decisions on exam locations are at the discretion of our Director.

Snow and Weather Cancellations: Danceartists is closed when Worcester Area schools are closed. In the case of government directives, Danceartists classes will be held online. Please look up cancellations at <http://www.cancellations.com>. Classes missed due to inclement weather and/or illness can be made up by attending other scheduled classes. Please email Danceartist's to arrange suitable make up lessons for your child. No credits or refunds for cancellations. However, there are many make up classes to select from and when necessary, Danceartist's will add extra lessons to the weekly schedule. Zoom Meeting numbers will be emailed to registered students by September 7, 2026.

Lessons missed due to illness may be made up by attending another class by arrangement with the director when a doctor's certificate is provided. Danceartists does not offer make up classes to students when they attend other activities instead of their dance class. Danceartists reserves the right to cancel or combine any classes or change the faculty teacher on short notice. Classes canceled by Danceartists may be made up by attending another scheduled lesson.

Danceartists Ballet Academy does not and shall not discriminate. We are committed to creating an inclusive, welcoming environment for all members of our community. At Danceartists Ballet Academy kindness, courtesy, honesty and good manners are important and we appreciate these fine attributes of character in all our students. Therefore we expect that all our students and parents abide by the following attributes:

Integrity: To conduct oneself with honesty, courtesy, kindness and respect. To lead by good example and honor commitments. To respect studio policies and interact with peers and authority figures maturely.

Character: To avoid gossip, criticism, or denigrating comments regarding any member of the dance community. To face concerns with maturity and dignity.

Behavior: Cliques, bullying, or disruptive behavior will not be tolerated. Dancers behaving inappropriately will be asked to leave.

Vandalism or destruction of property will result in immediate dismissal. No talking or disruptive behavior during class or disturbing another student from their classwork.

No running or yelling up the hallways or on premises.

All sales are final. No refunds, recompense, or compensation will be provided for tuition, summer programs, camps, competitions, or conventions. No exceptions.

Force Majeure: No refunds or compensation are provided if Danceartists Ballet Academy must change its method of instruction or close due to a Force Majeure event.

Payments: All late or bounced payments will incur a \$25 fine per incident

Danceartists Ballet Academy reserves the right to dismiss any student /adult who does not follow our Code of Conduct and/or School Policy. Students dismissed for violations will not receive a refund.
